REPORTS:

CITY MANAGER FRANK MARTZ provided an update regarding collection of Impact Fees on behalf of Seminole County. He explained Seminole County has not performed the work necessary to keep the fees up-to-date as required by law and has not responded to City Staff Members concerns. Mr. Martz provided historical information related to collection of Impact Fees; their use; information related to funding transfers and details of the most recent meeting held between City and County Staff Members. Because of the issues we have discovered and since the County has thus far not provided clarification; Mr. Martz recommended the City stop collecting the fees for them effective June 1, 2017. Discussion ensued. Mr. Martz asked Commission Members if they supported this course of action, to which Commissioners responded in the affirmative.

<u>COMMISSIONER REECE</u> asked if the "Crane" project was still on track. Mr. Martz indicated the project is moving forward. Growth Management Director John Sember indicated plans were re-submitted last Friday.

Mr. Martz noted Channel 55 is moving forward with their building. The schedule for building completion is November 2017 for the outside and January 2018 for the interior. Mr. Martz also indicated they are doing everything they are supposed to be doing to ensure the building is safe.

<u>MAYOR BATES</u> noted her attendance at a ceremony where Robbie Roberts, the City's oldest resident, received a Life-Time Achievement Award from the United States Navy.
